of Congress and about \$14 billion in new funding for aid to Ukraine, but no additional COVID-19 relief. Originally, the legislation included \$15.6 billion requested by the Administration for additional COVID-19 vaccines, testing, and medicine, but the House removed the provision after numerous Representatives objected to language rescinding (clawing back) about \$7 billion in unspent State and Local Fiscal Recovery Funds allocated under last year's American Rescue Plan Act. ...But 10-percent Set-Aside for Recovery Programs was not Included The FY2022 funding bill included some additional funding for SAMSHA's programs, but far short of what had been proposed for the substance abuse block grant (SABG), State Opioid Response (SOR) grant

September 30. The omnibus spending bill appropriates \$730 billion in domestic funding, a 7% increase over last year, and defense spending of \$782 billion, a 6% increase. The law includes more than 4,000

in the program in 14 years. The Administration had also proposed a 10-percent set-aside for recovery programs from the block grant funds, similar to the 20-percent set-aside that already goes to prevention programs. The House of Representatives had already passed a funding bill last year that included a \$1

program and Building Communities of Recovery (BCOR) grant program. The Biden Administration had proposed more than a \$1.5 billion increase in the SABG, which would have been the first regular increase

billion increase in the SABG with a 10-percent set-aside for recovery. A previous proposal in the Senate also included a more than \$1 billion increase in the SABG with the 10-percent set-aside for recovery. At the end of the day though, the funding package that was signed into law included only a tiny \$50 million increase in the SABG and a \$25 million increase for the SOR program. The appropriators also abandoned the 10-percent Recovery Set-Aside, which we always knew was problematic if a substantial increase in the SABG was not agreed to. MCRSP is continuing to work with Congress as they have already started work on the FY2023 funding package. FY2023 begins October 1 this year. To read the Omnibus Funding Package, click here. **Greg's Message** The Missouri legislature is returning from their Spring Break this week. Top on the agenda will be the FY2023 state budget. Just prior to the break, the House Subcommittee on Appropriations for Health, Mental Health and Social Services met to consider recommendations to HB3010, the budget bill that includes funding for DMH. The only proposed change for the DMH budget bill was an increase of \$1.9 million in authorization for DMH to spend additional funds from the state opioid settlement agreement. The

during this legislative session, 1,590 bills have been introduced in the House, 38 have passed the House and only 1 has passed both the House and the Senate (which was the supplemental budget bill for the current fiscal year). It remains unclear whether gridlock will be broken in the Senate Chamber to allow any

The MCRSP-supported HB2527 tax credit legislation remains in the House Rules Committee for Administrative Oversight. MCRSP is continuing to work to get the bill to the House floor soon. So far
