### DEAR FRIENDS AND ADVOCATES,

We are facing an immediate crisis that threatens the progress Missouri has made in combating substance use disorders and reducing overdose deaths. Proposed federal budget cuts to the Substance Abuse and Mental Health Services Administration (SAMHSA) put critical substance use recovery programs at risk. If these cuts proceed, Missouri will face dire consequences, including:

SAMHSA

Increased Overdose Deaths: Missouri has seen declining overdose fatalities since 2023, largely due to SAMHSA-backed initiatives. Cutting funding and oversight will reverse this progress and cost lives.

**Strained Criminal Justice and Healthcare Systems:** Without adequate treatment resources, more individuals struggling with substance use will end up in jails, emergency rooms, and hospitals, burdening taxpayers and reducing available care for others in need.

**Rising Homelessness:** The loss of funding will eliminate critical programs that support stable housing and employment for people in recovery, worsening Missouri's homelessness crisis.

**Economic Devastation:** Missouri communities depend on SAMHSA-funded initiatives to keep individuals in the workforce and support local businesses. Cutting these programs will have a ripple effect across our economy.

**Threats to Recovery Support Service Providers:** Many of Missouri's recovery providers, including faith-based organizations, rely on SAMHSA's State Opioid Response (SOR) funding to operate. Without this funding, many of these critical providers will be forced to close their doors, leaving those in need without support.

**Devastating Impact on Families:** Families will be torn apart as loved ones struggling with addiction lose access to life-saving treatment. Parents, children, and entire communities will suffer as a result of these cuts.

We cannot let this happen. We need your voice to protect these essential programs and demand that our federal representatives oppose these reckless cuts.
