MCRSP Presence at NARR 2023

The National Alliance for Recovery Residences (NARR) held its annual conference at Dearborn, Michigan on October 9-11, 2023 hosting approximately 275 attendees from across the United States, including 13 MCRSP Members. Dr. Rev. Marsha Hawkins-Hourd, MCRSP Board of Directors Chair was thrilled with the Missouri presence at the conference.

Newly hired MCRSP, Executive Director, Ann C. McGruder attended the conference reporting the NARR Conference was professional with excellent break-out sessions conducted by National Leaders. Some observations Ann gathered from attending are the growth and expansion of NARR with a focus on the expansion of the role of a national membership organization and how best to serve state affiliates. Areas of priority...state and federal advocacy and lobbying, state and federal networking and a profound focus on data collection and data analytics. A successful strategy will be to leverage local, state and national priorities to ensure alignment and messaging.

Andy Thomas, MCRSP Housing Director reported the conference content consisted of housing rights, equity in housing, access to funding and social modeling.

New Beginning Sanctuary Executive Director, Alon Fisch, highlighted several key points from the conference including NARR is adopting best practices for LGBTQ+ communities and the state affiliates will decide to adopt the same practices. Another key point Alon mentioned is studies have shown the success of an organization is not based on the clients, but instead on the strength and quality of the manager and employees, focus on building them up and you will improve your outcomes by Dr. David Best. Alon believes Patrick Kennedy, the son of former Congressman, Ted Kennedy was a great speaker and recovery advocate.

Merna Eppick with Simmering Center highlighted several items about the conference which include Drs. Amy Miricle and David Best. The term "reciprocal connection" has stuck with Merna. They also underscored the need to measure the recovery capital of house leaders to promote wellness among the residents. Another highlight Merna mentioned from Director Paulo DelVecchio, Director of the SAMHSA Office of Recovery and Recovery Housing "community, helping others and purpose." Merna also mentioned Patrick Kennedy and his encouragement of us to recognize the strength in numbers that recovery has built and mobilize for legislative support at the state and federal levels.

Ann C. McGruder said, "The focus on evidence-based and data-driven decisions has inertia from the top down and bottom up groups ensuring a great alignment for the industry with a translation to increased stature, branding, performance-based outcomes and funding. The holistic goal is the improvement of health and wellness for constituents."
